

UCONNECT LIVE COMMUNITY CONDITIONS OF USE

Description of the service

- 1.** Recipients of the UCONNECT LIVE Community (hereinafter the "Community") are exclusively persons of age (hereinafter "Users").
- 2.** Users can publish and make downloadable free of charge by other Users itineraries, performances, images, videos, texts, etc. (hereinafter the "Content") on the Community portal, accessible via www.driveuconnect.eu . FCA Italy S.p.A., with registered office at 200 Corso Agnelli, Turin, (hereinafter "FCA"), shall only provide hospitality and technological support for the publication of the Content and, under the current regulations, is not liable for the Content published, for which only the Users who sent it shall be deemed responsible.
- 3.** In accepting these Conditions of Use, Users acknowledge that they are exclusively responsible for all the Content uploaded by them in the interactive and multimedia context of the Community.

Community conditions of use

- 1.** Given that, due to its nature, the Community involves interaction with the various persons simultaneously connected to the Community, Users shall not transmit any Content that:
 - is clearly threatening, insulting, defamatory, injurious, obscene, vulgar, offensive, pornographic, blasphemous, racist, sexually explicit or indecent;
 - is inherently illegal or could incite the committing of unlawful acts, or provide information that encourages unlawful activities;
 - involves civil, administrative or criminal liability, or in any other way violates any applicable regulation;
 - in particular, violates regulations relating to intellectual property, publicity, copyright, privacy;
 - contains a virus or other harmful elements, or refers to websites that contain them;
 - contains advertising, promotions or any type of commercial messages;
 - implies or contains false information about the origin or false statements about the sender's identity.
- 2.** FCA reserves the right to remove, at its sole discretion, any Content that violates the conditions of the previous paragraph.
- 3.** Although not obliged to check the Content, in case of any violation - even if only presumed - of these Conditions of use, FCA can modify and/or delete all or part of such Content and, at its sole discretion, decide if to suspend and/or expel the User from the Community. Also, if FCA happens to discover the configuration of an offence by the User, it can inform the competent authorities.
- 4.** Notwithstanding the above, the User can notify FCA - via the email address customercare.it@driveuconnect.eu - of any content that is not pertinent and/or in violation of the Conditions of Use.

Release for use of the Content

- 1.** Users give FCA all rights of use and dissemination - through any means and medium - of the Content transmitted in conformity with the Conditions of Use as well as the Information Note given in the terms and conditions of use of the Uconnect LIVE services. All the above is foreseen for the maximum period permitted by the current regulations and without any territorial limit, and without involving any charge or obligation for FCA to pay any compensation by way of reimbursement or indemnity to Users or others parties.
- 2.** Users guarantee that:

- they are of age;
- they are aware of all their responsibilities under these Conditions of Use;
- they forgo, even for the future, any financial claim in relation to their own Content and the uses made of the same;
- they know FCA reserves the right to remove the Content at any time at its sole discretion;
- they shall hold FCA harmless from all direct or indirect damage, costs, charges and expenses, including any legal fees, that may be incurred by FCA as a result of participation in the Community even if said expenses are the consequence of legal proceedings against FCA, started by third parties or Public Authorities;
- the Content is original and that they are sole owners of all the related intellectual property rights and have obtained, from any person entitled, all the necessary consent and releases in relation to the Content also for the purpose of its use by FCA;
- nothing in the material sent is obscene, defamatory, blasphemous, or violates intellectual property rights, personality rights or any other third party rights.

Other legal conditions of the Community

1. FCA reserves the right, at its sole discretion, to remove, without notice and at any time, the registration of Users and the Content produced by them in case of even the presumed violation of the Conditions of Use, also at the request of interested third parties.

2. FCA reserves the right to modify these Conditions of Use at any time without notice and to also modify and/or remove the Community with the Content. Any changes to the Conditions of Use shall require their complete acceptance by Users.

3. These Community Conditions of Use are governed by Italian law. Any disputes between FCA and Users shall be settled exclusively by the Law Court of Turin.
